### I. Call to order:

Cooper has put in an application for a Special Use Permit for property he leases. Property has a 3 car garage on it but no house - possibly built in 2006. He needs to bring in plan, etc. next meeting, then a Public Hearing will need to be held the month after that after all residents within 300 ft are notified even those in Dover Twp. // Working with violations she sent notices out to. Mud, etc. is legitimately stalling progress at present but as weather improves people are making plans to work on getting in compliance. // 45 days or May 30 is deadline date for getting Denny's and all other open corrective actions completed - this is to accommodate mud this time of year.
