Chair, Rob Apoian, called the meeting to order at 7:00p.m. and led the Pledge of Allegiance to the flag.

ROLL CALL: Rob Apoian, Matt Minnick, Kevin Fisher, Scott Peters, and Pat Bournes, were all present. Leo Oswald and Bill Millner were absent

OTHERS PRESENT: Township Supervisor and Township Attorney.

APPROVAL OF MINUTES: Kevin fisher made a motion to approve the August 25, 2022, meeting minutes with the correction from July 28, 2022, to August 25, 2022, motion seconded by Pat Bournes, motion carried 5-0.

ADDITIONS TO AGENDA: None.

APPROVAL OF AGENDA: Kevin Fisher made a motion to approve the agenda for September 22, 2022, motion seconded by Scott Peters, motion carried 5-0.
