Al Boggs provided information from Citizen's Gas regarding the Natural Gas hook up. Leo made a Motion to move forward with the switch from Propane to Natural Gas. 2<sup>nd</sup> by Roxann, Motion Carried.</li> <li>3. Chris Bayless introduced himself to the Board and stated his interest in a Recreational Marijuana Facility. He was informed that Rome Township has Opted Out as this time, but the Planning Commission is reviewing options for an Ordinance in the future. He said he'll attend the PC meetings.</li> <li>4. Cambridge Township Officer Jeff Patterson provided information about the Onsted Schools Resource Officer. He stated that the initial school year had ran smoothly with the Resource Officer and continues to gain trust with the students. He plans to begin educating the students on different topics such as cyber security, etc. Officer Patterson asked Rome Township to support a 5-year contract, costing Rome Twp 25% of the total cost of \$16,000.00 annually.
