

Zoning Officer Appointment - Jeremiah made a Motion to appoint Scott Gosselin as the new Zoning Officer with a wage of \$400 per month and a payment of \$40 per visit above the salary of Supervisor. A 2nd was provided by Roxann. All in Favor. Motion Carried. 2. Roxann made a Motion and a 2nd by Robin to appoint the Supervisor to approve recommendations from the Len Co Dept of Equalization regarding Land Divisions. All in Favor. Motion Carried. This is how it's been done in the past and will remain the same with the elected Scott Gosselin as Supervisor. 3. Road repair contracts are not available. A Special Meeting will be scheduled. 4. Electrical Permits to be revised that will include a statement that any service of 400 amps or more will require a Zoning Permit prior to the electrical installation.
