Several threats were made and then anger, and concerns were thrown at Robin Robertson for work done on her property (3/4 of a mile east of him) in about 2005. He claims no permit was pulled. Robin assured him her husband was employed by the Road Comm and most certainly followed the required protocols. Still, his anger continued in that direction and eventually left the meeting, still very upset.
