A motion was made by Harvey to install a partition using the existing framing that will not exceed \$1,000.00 in cost, and seconded by Wayne.

The motion carried.

B. Terms of the planning commission members - Clerk will email everyone the excel spreadsheet with the information needed for PC terms.

C. Redoing the website. Do we want to hire someone to redo website and be the new webmaster?

A motion was made by Al to have the clerk get three bids on creating a new web site for Rome Township, and was seconded by Jeremiah.

The motion carried.

A motion was made by Wayne to purchase new code books for the building inspector & the electrical inspector that will not exceed the cost of \$500.00 and seconded by Jeremiah.

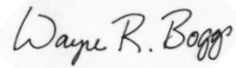
The motion carried.
